Student Participation

Dr. Karen List introduced students from both Hall and Conard High Schools participating in the 'Lead by Example' initiative. The students provided a summary of the program and its mission and goals. The positive role-modeling provided by senior students and specifically athletes and the collaboration with Link Crew members was highlighted. Board members discussed the powerful impact of the message delivered by students to students rather than adults and applauded the leadership initiative demonstrated by participants. Expanding the vision beyond the walls of the schools and into the community was explored.

Robert Milne, 3 Osage Rd., addressed the Board regarding Town revenue and property assessments.

Public Communications

Linda Dinapoli, 214 Mohegan Dr., addressed the Board regarding Town revenue and employee salaries and contracts.

Representatives from the organization, Growing Great Schools, led by Sallie Mancini and Stephanie Greco provided an update on their mission and vision to promote a culture of wellness and outlined the current initiatives underway. All were available to address the questions and concerns of the Board.

Board members expressed support for the group and their efforts and discussed changing school menus and updating the nutrition curriculum and the potential long-term fiscal impact on the district. The desire to continue an open dialogue, recognize cultural differences,

preferences and perspectives of students and families and provide an equitable distribution of resources to all schools was explored.

Mr. Schmitt moved, seconded by Mrs. Ma:

THAT the West Hartford Board of Education ratify the negotiated agreement between the West Hartford Public Schools Professional Employees CSEA, Local 2001 SEIU and the Board of Education for the period of July 1, 2012 through June 30, 2016

Mr. Rick Ledwith summarized the composition of the union members and the challenge of the negotiations due to the number of issues that needed to be addressed. The history of the mediation efforts and the changes and terms of the proposed contract were discussed. Mr. Rick Ledwith, Mr. Tom Moore and Mr. Chip Ward were available to address the questions and concerns of the Board.

The motion passed unanimously.

Dr. List announced that John Mastroianni, music teacher at Hall, was the recipient of the Connecticut Teacher of Year Award. She emphasized the award recognizes the value and commitment the district and community places on Fine and Performing Arts education. She shared additional awards received by staff and the district including Rosey Bonner for her statewide leadership, CAFE Communication awards and offered special recognition to Amy LaRose, graphic artist. The retirement of Norfeldt principal, Caryn Falvey was also announced.

Dr. List introduced the **Great by 8** presentation and Dr. Nancy DePalma, Ms. Kerry Jones, Ms. Mary Stone and Representative Beth Bye provided an update on the community partnership. The mission of **Great by 8** and the abundance of information available on their website and connections and involvement with a variety of town organizations were discussed. The data driving the community plan, the percentage of kindergarten students without preschool experiences, the efforts involved to assist with the transition to Kindergarten and the measures of the Early Development Instrument (EDI) were presented. All were available to address the questions and concerns of the Board.

Board members discussed the Kindergarten Transition Form and members applauded the comprehensive presentation and the collaboration and ability to identify and provide services to students in

need. Alignment of Board goals with previous initiatives and leadership by the Administration to recognize the value of early investment in the preschool years was highlighted and greater understanding of EDI and the use of and learning from data was sought.

Mr. Chip Ward provided an annual report comparing the projected and actual enrollments across elementary, middle and high school levels. There was a slight decrease in the actual enrollments. A summary of the average class sizes at all levels was detailed. Mr. Ward was available to address the questions and concerns of the Board.

Board discussion stressed the importance of class size issue for teachers and parents and specific schools and trends were reviewed. Research on recommended optimal class size and various factors that influence or impact learning was discussed.
