Megan Davis, Social Studies teacher at Conard High, introduced the ‘Girl Rising’ program. The presentation explained the leadership and mentoring service and participants from the middle and high school levels expressed their perspectives about the powerful program and their inspiration.

Mr. Putterman took a moment to recognized Dr. Karen List and her leadership over the last five years. He recapped the desired qualities and characteristics desired with the initial search and summarized how she embodied them throughout her tenure. He expressed his gratitude and extended best wishes on behalf of the Board.

Dr. Nancy DePalma, Ms. Shelley Solomon, Mr. Jamahl Hines and students from Hall and Conard High Schools explained the purpose of the program and creating a culture of acceptance and celebration. All were available to address the questions and concerns from the Board.

Board members applauded the eloquent presentation and the leadership action taken by the students.

Ms. Trish Molloy, Food Services Director, provided an annual report on the State Standards and reviewed the guidelines and laws pertaining to food content, availability of foods sold and approved exemptions.

Board members discussed potential risk of not approving and loss of funding and reviewed specific food exemptions.

THAT the Board of Education ratify the negotiated agreement between the Town of West Hartford Police Employee Association and the Board of Education for the period of July 1, 2013 through June 30, 2016

Mr. Rick Ledwith summarized the agreement with members of the Association. He expressed appreciation for the dedicated service of this group of employees specifically enduring all weather conditions.

Dr. List announced the appointment of Kristi Lavery as interim Principal at Duffy and Ryan Cleary as the new Morley Principal. She stated appointments for Bristow and Sedgwick Middle Schools would
